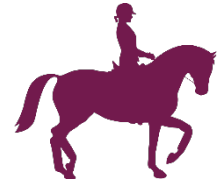

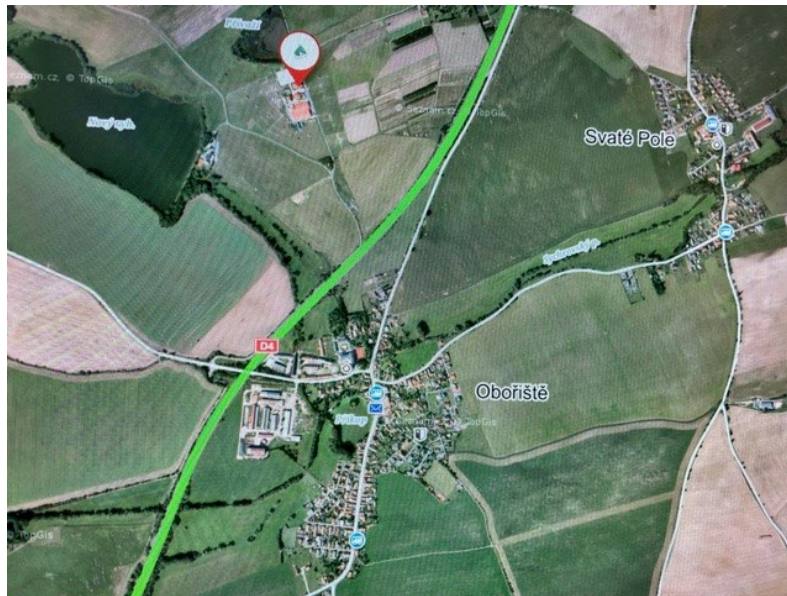

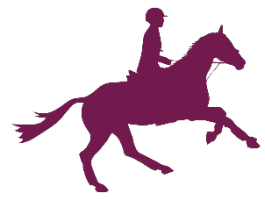

2.2 Conditions – Insurance

- All owners and competitors are personally responsible for the damages caused to their parties, by themselves, employees, agents or horses and they are accordingly most strongly advised to take out civil liability insurance, fully covering their participation in trails in their own country or abroad and that such insurance policy must be kept up to date.
- The organising committee is not responsible by competitors. Horses and competitors equipment remain under the riders/owners responsibility. Competitors are responsible for all costs resulting from accidents. The participants are also responsible for their horses and materials for the period of the competition.
- Participation in the event, use of the facilities of the entire facility, parking and stables is at your own risk. Parents are responsible for their children, leash for all dogs!
- The event. is subject to the valid regulations of CSWE and WAVE
- Entry fee and further fees due at the closing date. Registrations can be considered only after timely receipt of payment. Refunds (in full) in the event of restrictions related to government regulations regarding Covid-19.
- Permitted equipment of horses and riders in the individual classes according to regulations of the WAVE.
- The number of participants is limited; the organizer reserves the right to fill individual exams.
- The organizer and the organization exclude any liability for damages caused to the visitors, participants, horse owners and horses by negligence of the organizer, his representatives or vicarious agents. By submitting the application, each owner, denominator and participant recognizes the general and special provisions as binding. Any liability for spectators, riders and horses as well as material is excluded. The riders and owners are liable for any damage they cause to third parties and facilities of the organizer.
- Young riders till 18 years to wear a helmet in all tests. backprotector in maneability and speedtrail.
- The organising committee reserves the right to make any changes of the progame for the purpose of resolving any problems or unforeseeable circumstances.
- Movements of the horses between boxes, warming up and competition arenas should be also strictly respected to all other participants.
- All horses have to wear head numbers during the event.
- Vet-checks may be performed at any time during the competition.
- By submitting the application you agree to the terms of the competition described in these regulations and to the publication of the results with your surname, name and photo documentation from the competitons.
- If the date of entry is not enough participation, the organizer reserves the right to cancel the competition. In this case, the entries will be refunded in full.

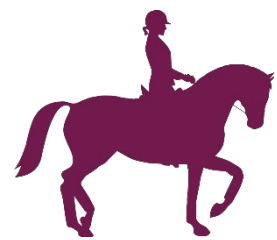

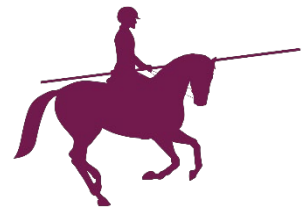

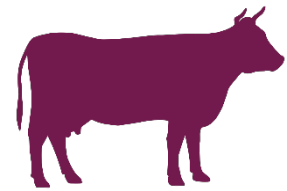

Parking Zone for trucks and trailers will be provided near the stables



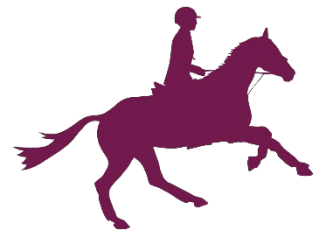

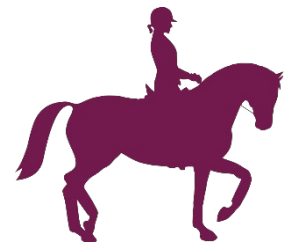
8. Veterinary regulations

All horses must have an equine identification Document issued by their countries of origin.

In the case of horse competitions, the horses' passports must be available for national veterinary supervision to the responsible person at the racetrack within 1.5 hours prior to the start of the event in which the horse participates.

The horse passport shall state that:

1. the horse has been vaccinated against **equine influenza** according to the vaccination schedule given by the vaccine manufacturer and must be immune. The last vaccination must be carried out no later than 14 days before the lead,
2. the horse has been tested laboratory for **infectious anemia of the horse EIA – Coggins test with negative result**; this examination must not be older than 12 months.
3. Horses that cross the border from the EU to the Czech Republic must have **TRACES** - this document is also necessary to participate in the Pedro Torres Cup. This document will be issued to you by your veterinary office based on the control of your horse by your veterinarian.
4. The horse has been vaccinated against **equine rhinopneumonia** caused by equine herpesvirus (EHV) according to the vaccination schedule given by the vaccine manufacturer and must be immune to the disease or the horse has been laboratory tested for the presence of equine herpesvirus by PCR from a nasal swab sample with negative results; this examination must not be older than 10 days (the date of sampling is decisive).



9. Code of conduct

FOR THE WELFARE OF THE HORSE

Considering that WAVE aims to meet the highest standards of equestrian competition and therefore pretends at all times to safeguard the welfare of the horse, we strongly recommend that at all times following principles are met by all the involved:

- That in all stages of the competition (during the preparation and training of competition horses) welfare must take precedence over all other demands
- Owners, trainers and judges have to be sure that horses and competitors must be fit, competent and in good health before they are allowed to compete
- The events OC have to pay careful attention to the facilities (involving competition areas, ground surfaces, stabling), weather conditions ,site safety and fitness of the horse for onward travel after the event.
- WAVE urges all involved with the sport to attain the highest levels of education in their areas of expertise
